General Terms:

A NON-REFUNDABLE DEPOSIT OF \$100 is required to reserve the vehicle(s). The total amount is due upon arrival of the vehicle(s) for service. A 24-HOUR NOTICE MUST BE GIVEN TO CANCEL THE SERVICE. The customer is responsible for the actions of all passengers and the enforcement of the contract rules. ATR Limousine Service is not responsible for injuries that occur after patrons have exited the vehicle(s) and is not responsible for items left unattended, damaged, lost, stolen or missing from the vehicle(s) during or after the contract period. If additional time is needed, arrangements must be made with the driver when he arrives. Without approved additional time arrangements, the vehicle(s) will be released from the contract at the predefined stop time.

Contract Rules:

No controlled substances (except alcohol) are allowed in the vehicle(s) at any time. No one under the age of 21 is allowed to drink alcohol inside any of the vehicle(s). No hanging or shouting out the windows or doors is allowed. No weapons are allowed inside any of the vehicle(s). NO SMOKING is allowed inside the vehicle(s). Breaking any of these rules will result in immediate termination of contract without a refund and could result in local or state prosecutions.

Additional Charges:

The cost to repair or replace any items destroyed, defaced, damaged or missing at the end of the ride will be charged to the customer. If anyone gets sick in a vehicle or otherwise discharges bodily fluid of any kind, in any vehicle, there will be a \$200 clean-up fee charged. If anyone gets caught smoking in a vehicle, there will be a \$100 clean-up fee charged. Additional time will be charged and 1/4 the normal hourly rate compounded every fifteen minutes.

Pick-Up/Drop Off Terms:

The contract period is for the amount of time required to drive from Point A to Point B ONLY. Customers are not entitled to one hour of limousine service for this fee. Any waiting time, either before or after transport, or any extra riding time, will be charged as the additional time as stated below.
